 - Unwanted compliments
 - Cursing
9. I agree to neither bring in nor possess any illegal items, drugs, tobacco, alcohol, fireworks, matches, cigarette lighters, knives, or weapons of any sort
10. I agree to dress appropriately. I understand that this agreement prohibits any clothing that has any reference to tobacco or alcohol products or gang affiliation.
